# History: An Interview with Secretary Leon Panetta

Hospice Giving Foundation CEO Siobhan Greene, had the honor of sitting down with Secretary Leon Panetta to learn more about his role with the passage of the 1982 law that made Hospice a benefit of Medicare. Secretary Panetta, a Monterey County native, was a member of the United States House of Representatives from 1977 to 1993; Director of the Office of Management and Budget from 1993 to 1994, President Bill Clinton's Chief of Staff from 1994 to 1997; CIA Director in 2009 to 2011; and Secretary of Defense from 2011 to 2013.

**Hospice Giving Foundation:** Welcome Secretary Panetta and thank you for joining me today for this conversation. Let's start with the history. You were very involved in the Medicare funding for Hospice Care. How did that come about, what sparked you to take this on?

**Panetta:** It's a great story and it's an example of how democracy can really work. Even today, there are members of Congress, including my own son, who ask me about that process. It remains an example of how people who are very concerned about the ability to help others, can turn to their representatives, and ultimately get the help they wanted. It's a real success story.

When I was a member of Congress representing the Central Coast, I used to have what I called 'Constituent Hours' where I would sit in my various offices and meet with the people and give them the opportunity to share their thoughts or views or their needs with me.

I was in the Monterey office when Dr. Jerry Rubin and a delegation of other individuals, that were involved in hospice care in this area, came in. They described hospice care and the fact that there was no Medicare coverage for something as important as the ability to care for older citizens who were terminally ill. I was moved by their arguments.

It was at a time when I remembered my mother, who died of cancer and my father had to care for her at home. I remember that very well and thank God, my father was able to help her, she wanted to be at home. And he made that possible. So, with that memory in my mind, I said, "this is really worth doing something about."

I went back to Washington and asked my staff to draft legislation that would provide Medicare coverage for hospice services. Bill Gradison, a Republican, also supported it with me, so we introduced the bill together. And before I knew it, because hospice services were becoming pretty common across the country, I almost immediately got about 140 co-sponsors in the House. I then talked with Bob Dole, who was a friend and the Republican leader on the Senate side. He was aware of the bill I put in, and he took the same bill and introduced it to the Senate. He again got a number of co-sponsors almost immediately.

We had some opposition from the Reagan administration; they thought it was going to involve additional costs. We made clear that the hospice

benefit would actually save money for Medicare and we were able to prove that point.

Before you knew it, we had close to 200 co-sponsors; when you have that many co-sponsors you can get a lot done. We moved it through the Ways and Means Committee, we moved it to the floor, it was part of another bill (Tax Equity and Fiscal Responsibility Act of 1982). We passed it overwhelmingly, it passed on the Senate side overwhelmingly, with Bob Dole's help. And before we knew it we had made a law that in fact provided for Medicare coverage for hospice services. It was a very proud moment, for not only me, but for all of those who were involved. It proved that democracy can work.

**HGF:** When I talk to people about what I do and mention the word hospice, it evokes very thoughtful reactions. What were the reactions in the early days? How did folks respond to having this kind of care in the community?

**Panetta:** The people that I talked to about hospice services really were looking for an alternative to their loved ones living because of life-supports and extreme measures in a hospital. They were not getting the kind of consulting services, the kind of support that can really helped them face the end of life. They were very concerned and looked at hospice care as a humane way to approach dealing with the end of life. I think, deep-down, people at that point really wanted the ability to have a loved one treated with compassion and dignity. Because, you know, as we approach the end of life it can get pretty tough depending on what you are suffering from. And people face a lot of pain that they are just not prepared for. Hospice services was really 'human caring' for the dignity of an





individual and how you could basically support that individual at a time of tremendous need. You know, we always look to healthcare to try to solve our problems and cure us for whatever problems we are facing. But, when you reach a point when there are no cures, and there is little you can do, people looked at hospice as a very positive way to confront the end of their life. I think it is something that health care needed, but also that people needed to be able to embrace what all of us face, though all of us resist to some extent. This gave us a positive way to be able to face the challenges that are involved with the end of our lives.

**HGF:** 2017 is Hospice Giving Foundation's 20th anniversary. Over the years we have contributed almost \$25 MM in grants to local (Monterey & San Benito Counties) end-of-life care providers. Our goal is to be here for the next 20, 40, 60 or more years. What would your vision be? There is more to do, so what would that look like to you?

**Panetta:** This is a great story. I think it's the story of how all of us can reach out and care for one another in a humane way. That's the great thing about this country. The one unique thing about America is that people care for one another, people care about their community, and they care for each another. This is what America is all about. The ability to get this done – to establish hospice funding – and then to have the Foundation taking root and be able to support these efforts through the generosity of contributors everywhere, was just a great 'one-two' in helping people deal with the challenges they had to face.

We've come a long way, we've had a lot of success. People know that hospice care is there and available to them. I am very proud of the fact that this community was really, in many ways, the beginning of that effort because of what we were able to achieve. So, my hope is, through the work of the Foundation, through the work of the hospice services, that we can all continue to work together to be able to make hospice care a reality for every family – the elderly but also the young who are facing those challenges. I hope that the Foundation and all the hospice services are here for a helluva long time so that we can continue to provide that dignity and compassion that all of us should be about.

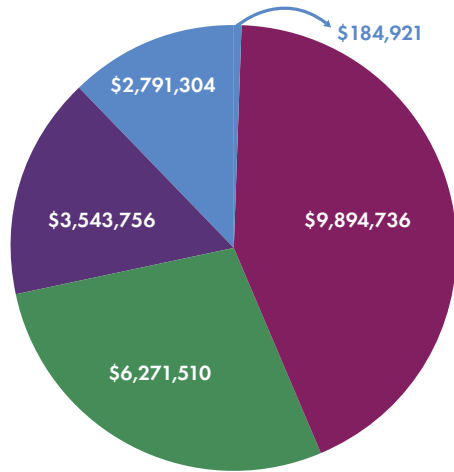

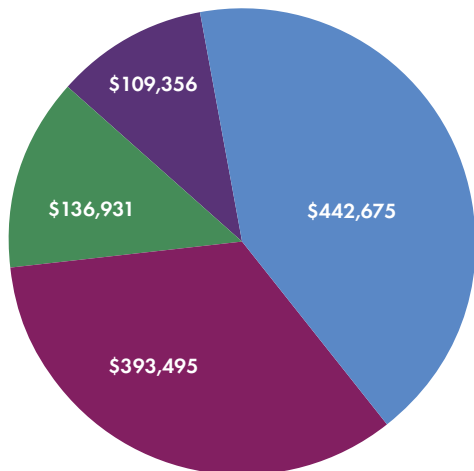
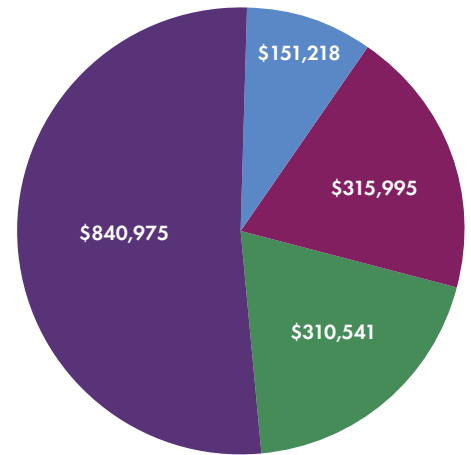


### NET ASSETS AS OF JUNE 30, 2017: \$22,686,227

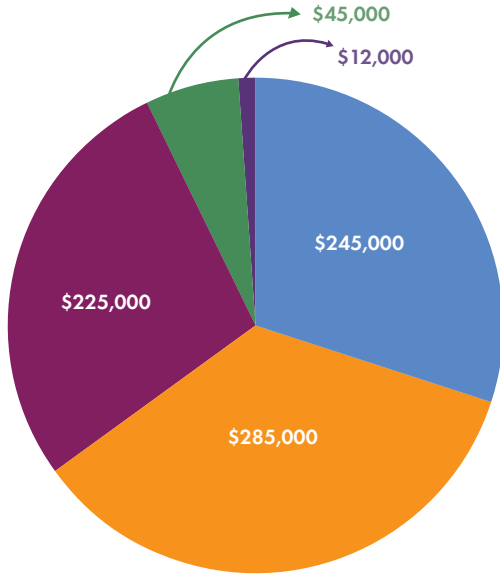

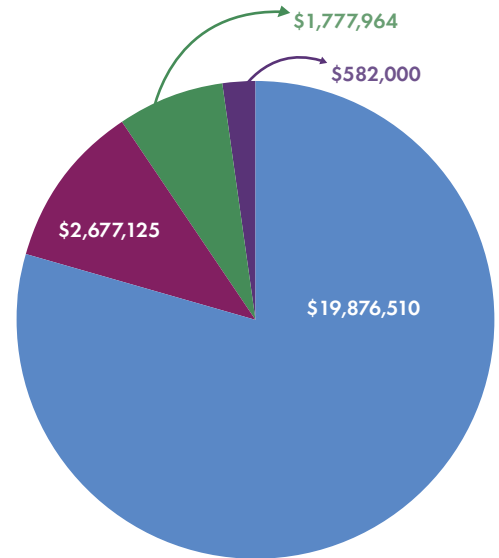

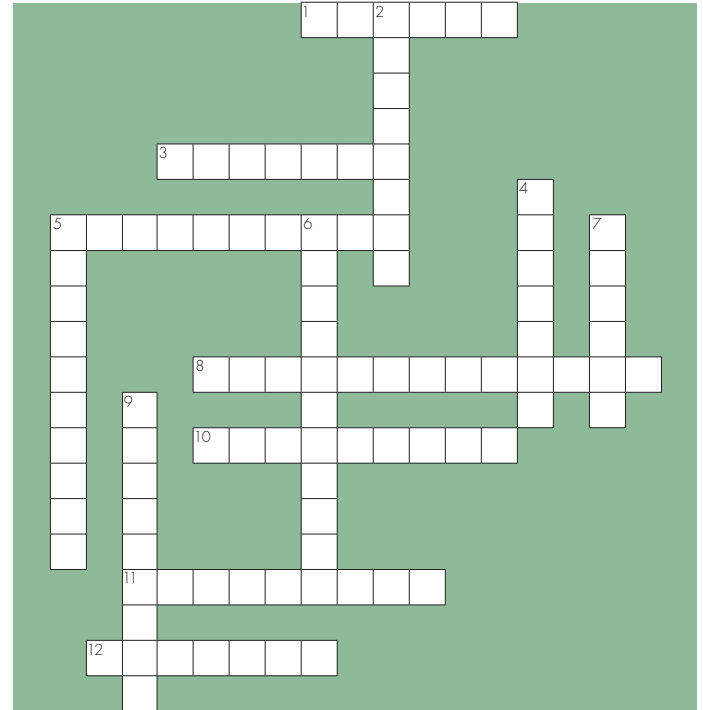
