HG Foundation sponsored three clinicians, from grantee agencies, to attend The Harvard Medical School Center for Palliative Care Practical Aspects of Palliative Care (PAPC) Course in September 2018. The course offered the multi-disciplinary audience information and skills needed to provide high quality palliative care to patients in a variety of settings. Our attendees deepened their understanding of Spiritual & Religious Influences, Care Factors related to Socio-Economics & Cultural Dynamics, Pain Management, and Communication Methods.

When telling a new patient or caregiver, or even my own friends and colleagues, that I am a 'palliative medicine specialist,' I am accustomed to the awkward moment of silence and, "huh?"

'Palliative medicine' is as old as medicine itself, though not by that name. The nurturing and comforting we associate with caring for a sick child or spouse; the anticipating and planning parents and doctors invest in preparing for a birth; and the tenderness and honesty with which a hospice team tends to the dying - these familiar and timeless values embody 'palliative care.'

The vast majority of modern medicine now seems devoid of comforting, honesty, anticipating, and planning. Crisis management and prevention of 'organ failure' have superseded caring for a whole, unique person.

The specialty of palliative medicine allows me to re-claim and practice those values that drew me to medical training. Palliative care attends to social, emotional, spiritual, as well as physical needs, in particular for those with serious or life-limiting illness.

I feel this movement has 'saved' us from the daily grind of modern medical practice. Palliative care delivers 'personalized' or 'whole person' care to people with the most serious and complex medical needs, including end of life. Support of this movement continues to grow through the generosity of philanthropy, as well as the foresight of the non-profit and scientific communities.

We owe the exponential growth and quality of palliative care services in Monterey County largely to Hospice Giving Foundation. From staffing to training to program development, the robust palliative care movement in our county would not exist as we know it without HG Foundation.

The Trajectory of Hope – What Makes Life Worth Living: *Defining Hope*, A Documentary by Filmmaker, Carolyn Jones

HGF: What inspired you, kept you engaged in the topic of end of life that so many people don't want to talk about?

CJ: Talking to nurses for *The American Nurse* book, I got really interested in the end of life experience in this country. The profession of nursing encounters so much life and death; nurses are in a particularly unique position to understand it. I was eager to dive into that world.

I'm sort of a 'manual' person. When I get a new stereo system, I read the manual. Yet, when I was thinking about the end of life, I saw so much complexity and so many unanswered questions. When do we make choices, how do we know when it's time to not have that surgery or take that extra round of chemo? I thought: there must be some kind of 'how-to' manual or guide on how to get to the finish line with dignity and have family members know what we want. I was so focused on that, which of course is a goofy notion because it's the most individual thing in life. We all have a powerful will to live and specific ideas that make this such an individual journey. I think sharing stories that help others navigate these waters helps us better understand what kind of things we might be facing and the choices we might have to make as we get closer to the end of life.

My goals were to witness, and to share, those stories that I was lucky enough to be a part of.

HGF: What surprised you in the making of *Defining Hope*?

CJ: What surprised me the most was **the unbelievable power of the will to live**. I was so struck by what mattered and what people talked about and what rose to the surface. Some of the things I thought or expected to encounter I didn't – we'd be talking about love, or the wind, or the earth, or these very, very simple beautiful things. **It wasn't always beautiful, but I was surprised by how often it was.**

HGF: Film is an interesting medium for such an intimate experience. We don't expect to see real people; we expect to see actors sharing a story. Talk to us about how film made this such a powerful tool.

CJ: I think a documentary film gives us this unique opportunity to witness what we might not ever have a chance to. Being with someone in real life; sitting there next to someone and finding out

what's important at the end of life – wow, what a gift that is and what a privilege it is to be with people and their families in that moment.

I began this as a hospice volunteer asking, 'May I talk with you about your life?' I wanted to sit and listen to someone share their story. People want to tell their story. We want to leave something behind, we want to be able to tell people what we are thinking and feeling. I think people were open to this idea, knowing they wouldn't be on this earth much longer. Sometimes family members welcome something like this, telling their loved one's story. To have a record of what someone was thinking at that stage of life could be a legacy they'd leave behind.

HGF: The film was powerful because the people were so diverse. I recall watching the film thinking: 'I can see a little of myself in this person or that person.' They were so genuine. I wondered how they got to the place where they were so able to share their feelings and thoughts.

CJ: The nurses made it work. They'd ask the patient: "I am already here talking to you about these things. Would you be willing to let others hear the answers to these questions that are so remarkable? Your journey is unique to you, but it can guide others. Would you be willing to share that?" That's kind of the beauty in all of it.

In terms of the diversity in *Defining Hope* – that's what we wanted and talked a lot about. Can we relate to this person; can we relate to that person; is this like your mother; is this a relationship we can feel comfortable watching?

The minute I started working on this film, as soon as I was sitting with the first patient, this wasn't a film about dying, it was a film about living. And because they were all dealing with a life-threatening illness, they were living really cherished, vital moments.

I watched this progression of the word hope – first hoping for a cure, then hoping to see a child get married, then hoping to die without pain, and then hoping to leave something behind that was meaningful. I watched so many people travel this trajectory.

We all die. Frankly, whether we have all the money in the world, or we don't, whether we are at home or in the hospital, we still

die. Is there any way — barring situations of untimely death — that we have any control over how we go through this journey? We have so much to learn. If we don't get our brains around this, we are missing an incredible opportunity.

Hospice care is the answer; it's as close as we are going to get to the guidebook. We all need guidance. It's a community way of thinking. These days we may not learn it from the elders in our family, but we can learn it. The sooner we wrap our heads around this conversation, the better.

I often think about my Dad, he saw his grandfather die at home. I think people in older generations had the benefit of witnessing the end of life. We've lost that. We move away, we don't have the conversations, we send our elderly away to nursing homes. What I've learned in this process has changed my life. It has been such a privilege.

Both of my parents died when I was working on this project and that was profound. But what was immeasurably helpful was that they planned everything. I knew so clearly what they wanted and that I could give them that. It doesn't take away the sadness or make it less hard, yet it brings enormous comfort.

HGF: And that your last loving gift to them was that you could honor their wishes.

CJ: If we could recognize what a gift it is to honor other people's wishes; being willing to listen; not turning away when people want to talk about death. The gift is leaning into that conversation, absorbing it, and knowing and not being afraid of it.

I wish we could help people develop a real understanding of what palliative care is, what hospice is, and how to gently move people into hospice care. I can't help but think about the home hospice care that Berthold Cohen had in **Defining Hope**. Over the course of 3 months, the hospice nurse helped bring Bert's wife into the realm of understanding what his choices were and why it was so important to respect his choices. That was a beautiful dance to watch. When I met her, she didn't think she could ever live a day without her husband. And now, she is out kicking up her heels, she's able to get out, gamble the slot machines, go get her hair done, and live a good life.

Education and Outreach

Over the past several years HG Foundation has taken a leadership role in creating a knowledge community for professionals, individuals, and families. Our focus is multi-dimensional: To inform and educate people about end-of-life services; to facilitate individuals' advance care planning for personal wishes and medical decision-making; and finally, to promote professional development and collaborations addressing issues in the end-of-life system of care. Approaches include small group workshops, community presentations, provision of resources, networking teams, and relevant topic presentations with expert discussants. In addition, the Foundation offers film screenings and discussions, including the acclaimed *Being Mortal* and the moving film from the perspective of nurses, *Defining Hope*.



Annual Symposium | May 2018

Healthcare professionals and the public participated in a day-long symposium on Alternatives to Pain Management featuring professionals focused on therapeutic touch, massage, meditation, and the use of medicinal cannabis. Video recordings of these workshops can be found on our website.

South County Advisory

In part as an outgrowth of the Stanford Alumni Consulting Team (SACT) project, an HG Foundation Advisory Council has been formed in South County. Currently this 7-member group, made up of community members and clinicians, is meeting at Mee Memorial Hospital quarterly to develop strategies to promote planning and access to care in this region. The purpose of this group will be to: (a) promote two-way, dialogue and information sharing on end-of-life desires, traditions, needs, and wishes, with resources and care options and (b) increase acceptance, preparedness, and utilization of services in South County. The group intends to host community gatherings in 2019.

Palliative Care Workgroup

A group of local clinicians has formed the Monterey County Palliative Care Collaborative. HG Foundation funds the operational costs, provides administrative support, and meeting space. The Collaborative, led by Dr. John Hausdorff, meets monthly and their first project is to work with Skilled Nursing Facilities (SNFs) to enhance utilization of palliative and hospice care. Their goal is to work together to improve quality of life for patients while honoring their treatment of choice.

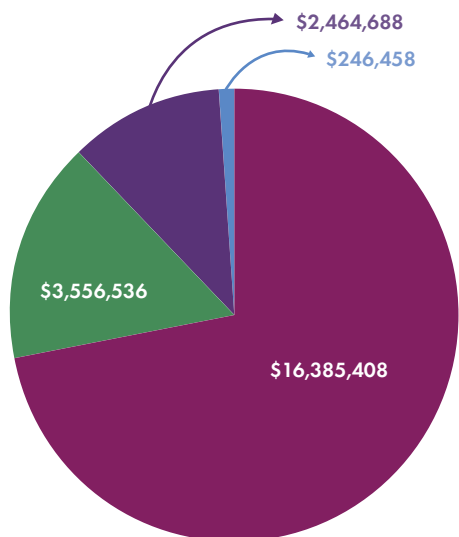

Latino Outreach

HG Foundation worked with the Stanford Alumni Consulting Team (SACT) this year to explore the reported underutilization of hospice care among Latinos in Monterey County. Our process with SACT involved a series of interviews to determine barriers, social and cultural dynamics, and possible accelerators for use of these services. Local findings were consistent with research from like-minded communities. Shared experiences and personal perspectives helped inform the Foundation about the needs unique to our communities. This information is being shared with local providers to problem solve and improve acceptance of and access to end-of-life services.

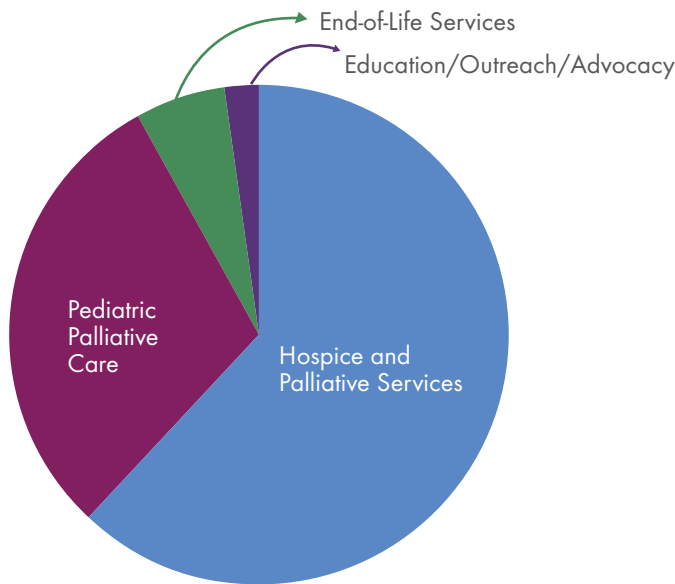
Impact: Grants

Through the generosity of our donors, Hospice Giving Foundation is able to award grants to non-profit agencies in Monterey and San Benito Counties providing dignified and compassionate care at the end-of-life.

In 2018 Hospice Giving Foundation awarded \$761,000 to twelve non-profit organizations in our community. Our Board of Directors takes great care in determining the most impactful ways to support a continuum of care through end of life. The cumulative giving from HG Foundation in its 21-year history proudly exceeds \$25,000,000. The generosity of our donors enables HG Foundation to enrich services and programs throughout our funding region. This investment has allowed our community to be at the fore front of excellent end-of-life care.

Here are some highlights from our 2018 funding cycle:

- Funding for hospice care included inspiring and innovative programming such as Hospice of Santa Cruz 'Camp Erin' for grieving children and music therapy.
- Specifically focused grants supported outreach to address under-utilization of end-of-life care in select Monterey County communities.
- Grants for palliative care providers helped fund clinical staff, membership in professional education organizations, and quality assurance programs.
- Grants to local pediatric providers supported families and their seriously ill children with in-home medical care, medical transportation, and a multitude of psycho-social support services.
- Programs serving families and communities included grief and bereavement support, care for families of Alzheimer's patients, and expanded end-of-life preparedness services in South County.
