### Biography

Dr. Stephen R. Connor is the Executive Director of the Worldwide Hospice Palliative Care Alliance, the global alliance of national and regional hospice and palliative care organizations advocating for hospice palliative care development worldwide.

Dr. Connor began his career as co-founder of the first hospice in Monterey and has worked in palliative care for the past 43 years. A researcher, licensed health psychologist, consultant, author, and educator, he served 11 years in leadership of NHPCO.

Dr. Connor has published over 125 peer reviewed journal articles, reviews, and book chapters on issues related to palliative care for patients and their families and is the author/editor of 5 books on palliative care.
