

## MORNING ALTARS WORKSHOP IMMERSION AGREEMENT

This Agreement ("Agreement") is made as of October 19, 2019, by and between MORNING ALTARS ("Artist") and Siobhan Greene of HOSPICE GIVING FOUNDATION ("Client") in reference to the Morning Altars events to be hosted on **Saturday, January 11th, 2020 at the Hidden Valley Music Center in Carmel Valley, California.**

### 1) COPYRIGHT

- a) Morning Altars maintains full rights over any and all images of mandalas, altars, and art pieces created by Day Schildkret

### 2) PROMOTIONS

- a) Client is required to use the following on all promotional materials:
  - i) *Day Schildkret of Morning Altars* or *Morning Altars*
  - ii) *Book Reference: Morning Altars: A 7 Step Practice to Nourish Your Spirit Through Nature, Art and Ritual*
- b) Use of images
  - i) Client is allowed to use approved images from promotional purposes and is to tag or mention *Day Schildkret of Morning Altars* or *Morning Altars* on all posts (when appropriate)
- c) Social media
  - i) Client is to use Morning Altars social media accounts on all promotional materials: @morningaltars
  - ii) Artist will promote event on all social media accounts
- d) Newsletter
  - i) Client will mention event in newsletters and other communications with proper links to Artist social media and website
  - ii) Artist will mention event in all newsletters and other communications with proper links to Client social media and website
- e) Client and Artist will conduct any and all marketing efforts to ensure a successful event

### 3) WORKSHOP LOGISTICS

- a) Client is responsible for identifying a location, communicating with attendees, and providing any necessary details with Artist
- b) Client will send a detailed "run of show" to Artist ahead of event
- c) Client is responsible for event space insurance as needed
- d) Artist will bring a workshop assistant (if needed), Client will provide additional support as needed.

### 4) COMPENSATION

- a) The Client agrees to pay Artist \$1500 for a 4-hour workshops

- b) Upon signing, Client will pay Artist half (½) of agreed upon fee
- c) Client will provide Artist with travel to event
- d) Client will provide Artist with accommodations during the event.
  - i) Artist will arrive the day before the event and leave the day after the event is complete.
  - ii) Accommodations shall be a hotel room or private room/bathroom in a residence
  - iii) Accommodations shall be cat-free
- e) Artist is responsible for making air travel arrangements.

#### 5) MERCHANDISE

- a) Artist maintains all (100%) of merchandise sales during the event
- a. Client will provide merchandise table/area for sales
- b) Artist will provide attendees with the opportunity for a book signing.

#### 6) TERMINATION

- a) Either party may terminate this Agreement at any time upon 15 business days of signing with written notice
- b) In the event of Client termination more than 15 business days after signing, Artist shall retain half the portion of the booking fee
- c) In the event of Client termination less than 15 business days before event, Artist is owed full portion of the booking fee.
- d) In the event of Artist termination more than 15 business days after signing, Client shall retain full portion of the booking fee

### EXHIBIT A

#### Description of Services

1. Artist will lead one 4 hour workshop featuring the Morning Altar's 7-step methodology, including teaching, discussion, foraging, creation, ritual and other interactive experiences.
2. Artist will provide a designed event flyer including a Morning Altar image.
3. Client will provide Artist with access to event space, help with gathering supplies, and conducting clean up as needed, promote the workshops, set up and lead all event logistics.
